Your Kemah Police Department engaged in **80** positive citizen contacts/interactions, handled **1420** enforcement service-related calls, performed **250** security checks, and generated **47** Offense/Incident Reports. Additionally, the Kemah Police Department completed **902** total Computer Aided Dispatch (CAD) related calls for service and executed **11** felony/misdemeanor warrants. Our Police Officers self-initiated **1060** calls for service.

Concerning traffic law enforcement, our officers issued **148** traffic-related citations and/or warnings, **49** citations to female citizens, and **99** citations to male citizens. K.P.D. received **123** hours of free law enforcement (public safety) services from reserved police officers, volunteers, and/or interns.

In addition, this report will encompass an incident summary category that will provide a brief synopsis of any significant incidents during the evaluation month. The information accumulated will be utilized to identify spatial concentrations of substantial incidents or offenses that require generating a police offense/incident report by City of Kemah Police Department Personnel.
