The purpose of this **September 2023 - Activity Monthly Report** is to provide the Mayor, City Council Members, and City Administrator with a detailed report of the services offered by the Kemah Police Department for the performance of the month of **September 2023**. Your Kemah Police Department engaged in **207** positive citizen contacts/interactions, handled **830** enforcement service-related calls, performed **575** security checks, and generated **59** Offense/Incident Reports. Additionally, the Kemah Police Department completed **287** total Computer Aided Dispatch (CAD) related calls for service and executed **22** felony/misdemeanor warrants. Our Police Officers self-initiated **1210** calls for service.

Concerning traffic law enforcement, our officers issued **168** traffic-related citations and/or warnings, **65** citations to female citizens, and **103** citations to male citizens. K.P.D. received **184** hours of free law enforcement (public safety) services from reserved police officers, volunteers, and/or interns.

In addition, this report will encompass an incident summary category that will provide a brief synopsis of any significant incidents during the evaluation month. The information accumulated will be utilized to identify spatial concentrations of substantial incidents or offenses that require generating a police offense/incident report by City of Kemah Police Department Personnel.
