It is further ORDERED that during the deferral period that Defendant:

1. Is not currently on Deferred Disposition for any other violation;
2. Will not commit any violation against the State of Texas or the City of Kemah;
3. **If under 25 years of age, YOU MUST complete an approved driving safety course;**
4. For No Insurance deferrals only, you must provide proof of valid insurance and keep insurance during the deferral period with no lapses in coverage;
5. When you receive a Confirmation Email back then you may pay your fine

It is further DECREED that at the conclusion of the deferral period, if the defendant presents satisfactory evidence that he/she has complied with the requirements imposed, this Court shall dismiss the case; that upon such dismissal the sum submitted above will serve as a special expense; and that failure to pay your fees by the deferral date or receiving a violation during your deferral period will violate your Deferred Disposition Order. Failure to comply with any part of the Deferral Order will result in a fine equivalent to the special expense fee be due in full and will result in a conviction on your driving record.
